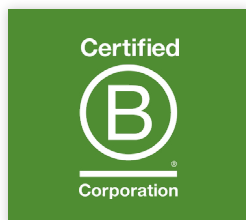

This ambition reflects the urgency and commitment expressed by Welsh Government to tackle climate change and to respond to an increased focus by consumers to purchase products with minimal environmental impact and ethically produced from sustainable supply chains. A survey from Deloitte in the 12 months to March 2021, found that 49% of consumers had bought more seasonal produce, 34% chose brands that have environmentally sustainable practices, and nearly one in three consumers claimed to have stopped purchasing certain brands or products because they had ethical or sustainability related concerns about them.

It seems likely that in the long run, those retailers and manufacturers who can demonstrate business responsibility through sustainable improvements that prioritise environmental, social, health and quality values will be most favoured by consumers. The Welsh Government is supporting the sustainable journey for responsible businesses within the food and drink industry in Wales. This will be supported through a number of existing and new sustainability initiatives:



B-Corp accreditation grant: [B-Corp](#) is considered as an international gold standard for sustainability. This initiative will reimburse up to 100% of fees for the first year. Decarbonisation & Covid Challenge Fund: This initiative aims to fund collaborative projects that can deliver innovative solutions in relation to the decarbonisation agenda, whilst aiding the recovery of the Welsh food and drink industry that has been adversely affected by the pandemic. Backing Local Firms fund: The Welsh Government's 'Backing Local Firms' fund is aimed at helping Welsh firms overcome specific issues and barriers they face when doing business with the public sector. The £1m fund, organised under the Foundational Economy programme, will be launched in October 2021 and will run to March 2022. The fund is aimed at helping local firms in the three foundational economy sectors of Food, Green Skills/Retrofit and Social Care. For more information, please email karen.combs@gov.wales

[Skills Cymru](#) is delivered by Lantra and supports businesses to train and upskill their employees. The project can support businesses with the cost of completing statutory, non-accredited and bespoke training courses in a wide range of subjects from business management, export, food

safety, health, sustainability and safety to engineering and machinery related training. Next month a new fully funded Sustainability Training Programme for Food and Drink industry will be available. The programme will equip individuals with the knowledge on why and how businesses need to become more sustainable through three main pillars – **People, the Planet and Product**. they sell, the way they make them, and the skills of their workforce. At the heart of this business transformation will be embracing the potential of the technology of today and working in partnership to tackle the challenges of tomorrow through business resilience and manufacturing sustainability support. AMRC Cymru have set up a team that spans a broad range of expertise, whilst benefiting from the broader AMRC and Catapult community throughout the UK.

- AMRC/Cymru are engaged on a number of innovative sustainability projects in Wales.
- Polytag** is an ambitious start-up technology business to enable and build packaging circular economy platforms. In line with the Welsh Government ambition to adopt a Digital Deposit Return System, this pilot project is validating an on-pack labelling process to tag and trace their packaging journey.
- EBS Automation** explores advanced packaging machines for cellulose packaging and also the development of a machine that can condition Polypropylene to behave like PET for new food packaging materials.
- Iceland is working with the Bio-composites Centre** to develop moulded pulp fibre-based packaging for food containers.
- Food and Drink Packaging** is a strategically important area for AMRC/Cymru; along with partners FDF Cymru, their ambition is to build collaborations that solve challenges within the industry by the application of advanced technologies.
- AMRC Cymru approaches each engagement from a partnership and collaboration perspective. This is the key to working in harmony to identify and solve a number of different energy efficiency and packaging challenges through the adoption of advanced technologies that will provide support across all pillars of sustainability. 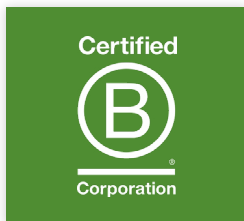
